- (3) Before submission of the bids, bidders are required to make themselves fully conversant with the complete bid specifications so that no ambiguity arises at a later date in this respect.
- (4) The bidders to be qualified for this work must have executed works of a similar nature. Complete sets of Bidding Documents for the above works may be purchased by bidders or their representative on submission of written applications along with relevant experience details to the address given below and upon payment of non-refundable fee of Nu./Rs. 5,000.00 for each package mentioned above in the form of a cash/demand draft in favor of General Manager, Finance & Accounts Department, Bhutan Power Corporation Ltd., Thimphu payable at Bank of Bhutan, Thimphu. The BPC shall not be responsible for loss of documents or delay in dispatch through post. Further, the issuance of documents will not construe automatic qualification of bidders.
- (5) The Bidder(s) are required to enclose duly filled and signed Integrity Pact (IP) given in the bidding document at the time of submission of their respective bids, failing which their bids will be rejected.
- (6) Bid must be accompanied by Earnest Money/Bid Security for respective package as mentioned above in the form of Bank Draft or Bank Guarantee in the prescribed Performa given in the Bidding documents
- (7) Sealed bid complete in all respects may be submitted to Executive Director, Development & Construction Department, Bhutan Power Corporation Ltd., Thimphu up to 1500 hours on February 22, 2010 and shall be opened on the same day at 1600 hours in the Conference Hall of BPC in the presence of the bidders' or their authorized representatives who choose to attend. Only one authorized representative shall be allowed to attend the opening with an authorization letter from the bidder.
- (8) The BPC reserves the right to reject or accept the bids without assigning any reason.
- (9) All bids must be in Ngultrum.
