## 2. INSPECTION

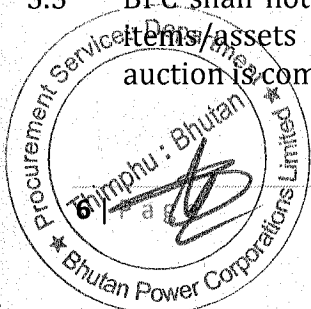
2.1 The intending bidders are requested to inspect the unserviceable items/assets and vehicles at respective regions/places identified during working hours from 0900 hours to 1700 hours (During working days i.e Monday to Friday) from 2<sup>nd</sup> November to 16<sup>th</sup> November 2022 with prior appointment from the Chief Manager, RSD, Phuntsholing, Officiating Manager, ESD, Thimphu and Senior Managers of ESD, Samdrup Jongkhar and RSD, Gelephu respectively.

2.2 It shall be assumed that the interested bidders bidding for the unserviceable items/assets and vehicles have inspected the said items at their own cost before bidding and the bid is offered at their own judgment.

2.3 Not more than two person per bidding document/Money receipt shall be permitted to do one-time inspection of the unserviceable items/assets and vehicles for security reason since auction materials are stored at stores premises.

## 3. CONDITION OF THE ITEMS.

- 3.1 The items offered for auction will be sold without any representation, warranty, or guaranty as to the quality, condition, size, or kind, or that the same is in condition or fit to be used for the purpose for which intended, and no claim for any allowance or deduction upon such grounds shall be considered after the bid opening or bid is awarded.
- 3.2 The bidders are requested to inspect the unserviceable items/assets and vehicles specified as below in Clause.10 Price schedule within the time frame indicated in Clause 2.
- 3.3 BPC shall not entertain any disputes with regard to the quantity of unserviceable items/assets and the vehicle's model number, availability of parts etc. once the auction is completed.

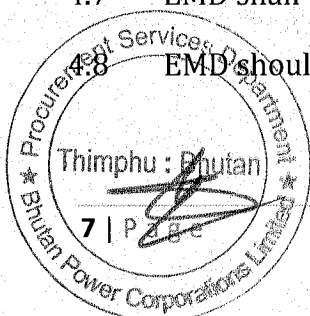


- 3.4 The RSTA validity of the vehicle is mentioned in the vehicle documents and therefore the winning bidder must take over the vehicle from BPC prior to expiry of its documents validated by RSTA. The original registration books and other documents shall be surrendered to the RSTA after the payment of transfer fee by the winning bidder. The bidder shall be completely liable for any penalties on the expiry of vehicle documents after the auction is over.
- 3.5 BPC shall not be responsible for any bid price disputes once the auction is completed and bid is awarded.
- 3.6 Except loading of the items, the winning bidders are not allowed to carry out any work like Cutting/Dismantling/Repairing of any equipment or its parts thereby to ease the transportation within the BPC auction premises.
- 3.7 The winning bidder shall lift all the items of the particular lots that they have won in the auction and should not leave unwanted items at the auction yard. EMD shall be forfeited if the unwanted items from lot that they have won are left behind.
- 3.8 The successful bidders are fully responsible for any sort of taxes/charges once the auction is over.

#### 4. **EARNEST MONEY DEPOSIT (EMD)**

- 4.1 The Earnest Money Deposit (EMD) must be submitted along with the sealed bid in the form of Demand Draft/Cash Warrant/Bank Guarantee/Cash from any of the financial institutions in Bhutan indicated against each lot. For electronic bids, original copy of EMD must be submitted to either of above mentioned offices ( mention EMD No. on the envelop).
- 4.2 The EMD shall be drawn in favor of "Director, Finance & Accounts Services, Bhutan Power Corporation Limited, Thimphu, Bhutan" payable at any Bank/Financial Institutions in Bhutan.
- 4.3 Any bid not accompanied by an acceptable EMD shall be treated as non-responsive and rejected.
- 4.4 EMD should be submitted for individual LOT. Combined bid security will not be accepted and bid shall be rejected accordingly.
- 4.5 The EMD so submitted shall not be considered as first/part payment for the successful bidders.
- 4.6 Unsuccessful bidders shall collect their EMD immediately upon completion of the award.
- 4.7 EMD shall be forfeited if the bidder withdraws its bid after the bid opening.

4.8 EMD should be valid for 30 days.



## 5. BID SUBMISSION

- 5.1 The sealed bid must be submitted at the address specified no later than or before 1700 hours on 16<sup>th</sup> November 2022. The bids shall be opened at 10:00 hours on 17<sup>th</sup> November 2022 in the above specified regions. The award of the bid shall be decided on the same day.
- 5.2 Any bid received after the deadline for submission of bids shall be rejected and returned unopened to the bidder.
- 5.3 The rates and the prices shall be quoted by the bidder entirely in Ngultrum and the payment shall be made in Ngultrum.
- 5.4 Bidder shall submit the rate in the **Price Schedule** provided without any alterations. In case of discrepancy in the quoted price (In figure) and quoted price (In words), the quoted price (In words) shall prevail and the bid price shall be corrected accordingly.
- 5.5 BPC, at the address given in this Bid document, will, upon request, provide additional information concerning the items/equipment/vehicle to facilitate preparation of bids. Each bid submitted shall be deemed to have been made with full knowledge of all terms, conditions, and requirements contained in this Bid document.
- 5.6 Signed letter of undertaking should be submitted along with the sealed bid. (Annexure1)

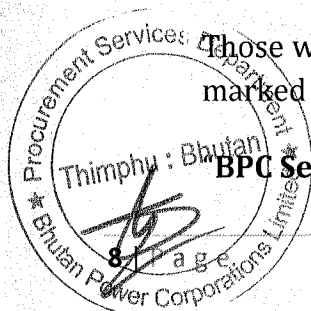

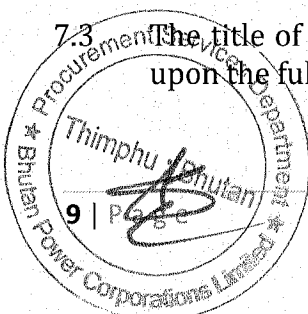
## 6. AUCTION AWARD.

- 6.1 The bid price offered by the highest bidder shall be awarded .
- 6.2 In the event if particular lot does not fetch the estimated price of BPC, the BPC Auction Committee reserve the right to award or not.
- 6.3 Letter of Award by BPC Auction Committee shall be deemed to have been sufficiently given upon written notification to the highest bidder or his duly authorized representative at the address indicated in the bid documents. Similarly, the unsuccessful bidders will be notified with letter of regret by the Auction Committee within 10 days from date of opening/award.
- 6.4 The Invitation for Sealed Bids, and the bid when accepted by the Auction Committee of Bhutan Power Corporation Ltd., shall constitute an agreement for sale between the successful bidder and BPC. Such agreement shall constitute the whole contract to be succeeded only by the formal transfer of items, unless modified in writing and signed by both parties. No oral statements or representations made by, or for, or on behalf of either party shall be a part of such contract.
- 6.5 During evacuation of the unserviceable items/assets and the vehicles, the winning bidder must produce all relevant documents such as letter of Award to concern divisions and receipt of payment so that the auction materials can be issue through Challan to the winning bidders.
- 6.6 The change of ownership of the vehicles should be effected within 15 days from the date of the auction and the transfer tax as applicable will have to be paid to the RSTA by the successful bidder.

## 7. PAYMENT

- 7.1 Upon full payment of value by the successful bidder in favor of BPC within 10 working days from the date of auction, BPC shall provide the necessary documents required for transfer of titles/ownership to the successful bidder or authorize for evacuation/lifting of the auctioned items. The evacuation/lifting of the unserviceable and the vehicle shall be at the cost of the successful bidder.
- 7.2 The winning bidder shall take complete delivery of the items at their own cost within 15 days from the issuance of letter of award by BPC/Regional Auction Committee upon producing full payment money receipt. In the event successful bidders fail to take complete award materials from the auction yard within stipulated time, **EMD shall be forfeited.**

- 7.3 The title of auctioned property shall be transferred to the successful bidder only upon the full payment of value of property by the successful bidder.



7.4 The successful bidder shall be liable to pay all taxes and duties applicable in the Kingdom of Bhutan with regard to transfer of properties.

## 8. DISPUTES/ CONMPLAINTS

8.1 BPC shall not entertain any disputes with regard to the items/equipment/vehicles once the auction is completed and awarded.

8.2 BPC shall not be responsible for any bid price disputes once the auction is completed and the bid is awarded.

8.3 No complaint from the bidder shall be entertained once the auction is completed.

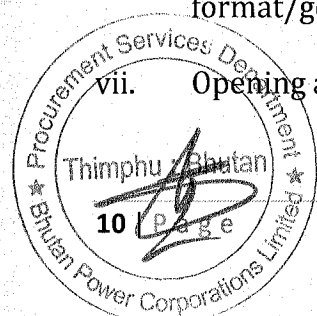
8.4 In the event of any dispute arising during the auction with regard to the procedures on the day of auction, the decision of Auction Committee shall be final and binding.

8.5 The BPC's Auction Committee reserves the right to accept or reject the bids or to cancel the bids without assigning any reasons there off.

8.6 The auction procedure shall be as per the established BPC Auction Procedure. The Chairperson of the BPC Auction Committee shall read out the procedure before the auction begins on the day of the auction.

## 9. Procedure on the day of auction opening (17<sup>th</sup> November 2022)

- i. **0930 hours:** All the Committee members to be present at Conference Hall of respective regions
- ii. **0945 hours. – 1000 hours:** All the bidders who have purchased and submitted the bids needs to register and proceed to auction hall by producing money receipt issued during the time of bid registration/submission. Those bidders who have not submitted the sealed bids as per our record or not producing money receipt during the entry shall not be permitted to enter the auction hall. This is mainly to restrict the entry of non-potential participants in the auction halls.
- iii. Only one person per money receipt will be allowed to attend the auction
- iv. **1000 hours:** Arrival of Auction Chairperson and the Auction Committee members invited from different sectors if any.
- v. **10:10hrs:** The Chairperson shall lead the auction proceedings.
- vi. **10:20 hours:** The Chairperson shall invite a BPC official to announce the property to be auctioned and other relevant information and begin auction by opening the region wise sealed bids one by one and recording the entry as per designed format/google sheet.
- vii. Opening and updating of bid will start in following sequence.

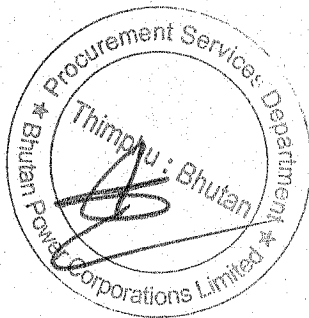


1. Samdrup Jongkhar Region
2. Phuntsholing Region.
3. Gelephu Region.
4. Thimphu Region.

**1030 hours.** Start opening of bids starting from bid serial number and sequence of regions from the above listed regions. All the bids opened shall be checked of offered price and promptly recorded in the format/google sheet, the EMD submitted along with the bid will be checked, recorded and evaluated for completeness before the opening of second bid by the Finance & Account team. Subsequently, all the bids will be opened one by one and checked for completeness and recorded in the designed format/google sheet so that result could be displayed and read out and awarded towards the end by printing and signing of documents by the Auction Chairperson . The Chairperson will read the final recorded result and the successful bidders will be awarded letter of award.

- viii. The successful bidder shall sign the Undertaking stating that he/she shall abide by the Terms & Conditions of bid document.

The auction processes to move on till the completion with the decision from the Auction Chair person.
