The following terms and conditions shall govern the bidders for auctioning off Vehicles and Unserviceable items through the Hard Copy in a Sealed Envelope.

**1. THE SCOPE OF OFFER**

Bhutan Power Corporation Limited will dispose-off the following Vehicles and Unserviceable items as specified below.

## **2. INSPECTION**

- The interested bidders are requested to inspect the Vehicles and Unserviceable items from 0900 hours to 1700 hours (During working days i.e Monday to Friday) from 02/11/2024 to 25/11/2024 with prior permission from the concerned Senior Manager.
- It shall be assumed that the interested bidders bidding for the Vehicles and Unserviceable items have inspected the said items at their own cost before bidding and the bid is offered at their own judgment.
- Not more than two persons per bid /Money receipt shall be permitted to do one-time inspection of the Vehicles and Unserviceable items for security reasons since auction materials are stored at open yard.

## **3. CONDITION OF THE ITEMS.**

- The items offered for auction will be sold without any representation, warranty, or guarantee as to the quality, condition, size, or kind, or that the same is in good condition or fit to be used for the intended purpose and no claim for any allowance or deduction upon such grounds shall be considered after the bid opening or bid is awarded.
- The bidders are requested to inspect the Vehicles and Unserviceable items specified within the time frame indicated in Clause 2.
- BPC shall not entertain any disputes about the vehicle's model number, availability of parts, etc. once the auction is completed.
- The original registration books and other documents shall be handed over to the winning bidder upon making full payment. Thereafter, the successful





- bidder shall be completely liable for any penalties on the expiry of vehicle documents after the auction is over.
- e. The winning bidder shall immediately remove any official identification like BPC Logo/Company Name from the vehicles before it is put into service.
  - f. BPC shall not be responsible for any bid price disputes once the auction is completed and the bid is awarded.
  - g. Except loading of the items, the winning bidders are not allowed to carry out any work like Cutting/Dismantling/Repairing of any equipment or its parts thereby to ease the transportation within the BPC auction premises.
  - h. The winning bidder shall lift all the items of the lots that they have won in the auction and should not leave unwanted items at the auction yard. EMD shall be forfeited if the unwanted items from lot that they have won are left behind.
  - i. The successful bidders are fully responsible for any sort of taxes/charges once the auction is over.

**4. EARNEST MONEY DEPOSIT (EMD)**

- a. The Earnest Money Deposit (EMD) must be submitted along with the sealed bid in the form of Demand Draft/Cash Warrant/Bank Guarantee from any of the financial institutions in Bhutan indicated against each lot.
- b. The EMD shall be drawn in favor of "Sr. Finance Officer, Finance & Accounts Unit, Bhutan Power Corporation Limited, Gelephu/Phuentsholing, Bhutan" payable at any Bank/Financial Institutions in Bhutan.
- c. Any bid not accompanied by an acceptable EMD shall be treated as non-responsive and rejected.
- d. EMD should be submitted for individual LOT. Combined EMD will not be accepted, and such bid shall be rejected accordingly.
- e. The EMD so submitted shall not be considered as first/part payment for the successful bidders.
- f. Unsuccessful bidders shall collect their EMD after 10 working days from the date of opening.
- g. EMD shall be forfeited if the bidder withdraws its bid after the bid opening.
- h. Vehicle EMD shall be returned to the successful bidder only upon producing the change of ownership certificates.
- i. EMD should be valid for 60 days from the date of opening.



**5. BID SUBMISSION**

- a. The sealed bid must be submitted to the above-mentioned addresses on or before 1100 hours of 25/11/2024. The bids shall be opened at 1400 hours on 25/11/2024 in Conference Hall, BPC, Gelephu and Phuentsholing. The award of the bid shall be decided on the same day.
- b. Any bid received after the deadline for submission of bids shall be rejected and returned unopened to the bidder.
- c. The rates and the prices shall be quoted by the bidder entirely in Ngultrum and the payment shall be made in Ngultrum either by cash or bank transfer.
- d. Bidder shall submit the rate in the Price Schedule provided without any alterations. In case of discrepancy in the quoted price (In figure) and quoted price (In words), the quoted price (In words) shall prevail, and the bid price shall be corrected accordingly.
- e. BPC, at the addresses given in this Bid document, will, upon request, provide additional information concerning the Vehicles and Unserviceable items to facilitate preparation of bids. Each bid submitted shall be deemed to have been made with full knowledge of all terms, conditions, and requirements contained in this Bid document.
- f. Signed letter of undertaking should be submitted along with the sealed bid. (Annexure1)
- g. The bids in Hard Copy in a sealed envelope must be submitted to the above-mentioned BPC Office, and marked as:

**"BPC Sealed Bid for Vehicles and Unserviceable items"**

**"Do Not Open Before: 1400 Hours of 25/11/2024"**





## **6. AUCTION AWARD.**

- a. The bidder with the highest bid shall be awarded.
- b. In the event, if a particular lot does not fetch the realizable price of BPC, the BPC Auction Committee reserve the right to accept or reject the award.
- c. Letter of Award by BPC Auction Committee shall be deemed given upon issuance of written notification to the highest bidder or his representative at the address indicated in the bid documents.
- d. The Invitation for Sealed Bids, and the bid when accepted by the Auction Committee of Bhutan Power Corporation Ltd., shall constitute an agreement for sale between the successful bidder and BPC. Such agreement shall constitute the whole contract to be succeeded only by the formal transfer of items, unless modified in writing and signed by both parties. No oral statements or representations made by, or for, or on behalf of either party shall be a part of such contract.
- e. During evacuation of the Vehicles and Unserviceable items, the winning bidder must produce all relevant documents such as Letter of Award and receipt of full payment to the concerned office.
- f. The change of ownership of the vehicles should be affected within 20 working days from the date of the auction or BCTA date whichever is earlier and the transfer tax as applicable will have to be paid to the BCTA by the successful bidder.

## **7. PAYMENT**

- a. Upon full payment of the value by the successful bidder to BPC within 10 working days from the date of award, BPC shall provide the necessary documents required for transfer of titles/ownership to the successful bidder or authorize for evacuation/lifting of the auctioned items. The evacuation/lifting of the Vehicle and Unserviceable items shall be at the cost of the successful bidder.
- b. The winning bidder shall lift all the items at their own cost within 20 working days from the issuance of Letter of Award by BPC Auction Committee and upon producing full payment money receipt. In the event successful bidders fail to lift all the materials from the auction yard within stipulated time, *EMD shall be forfeited.*





- c. The title of auctioned property shall be transferred to the successful bidder only upon the full payment of value of property by the successful bidder.
- d. The successful bidder shall be liable to pay all taxes and duties applicable in the Kingdom of Bhutan pertaining to transfer of properties.

#### **8. DISPUTES/ CONMPLAINTS**

- a. BPC shall not entertain any disputes regarding the Vehicles and Unserviceable items once the auction is completed and awarded.
- b. BPC shall not be responsible for any bid price disputes once the auction is completed and the bid is awarded.
- c. No complaint from the bidder shall be entertained once the auction is completed.
- d. In the event of any dispute arising during the auction with regard to the procedures on the day of auction, the decision of Auction Committee shall be final and binding.
- e. The BPC's Auction Committee reserves the right to accept or reject the bids or to cancel the bids without assigning any reasons there off.
- f. The auction procedure shall be as per the established BPC Auction Procedure. The Chairperson of the BPC Auction Committee shall read out the procedure before the auction begins on the day of the auction.

#### **9. PROCEDURE ON THE DAY OF AUCTION OPENING (25/11/2024)**

- a. 1400 hours: All the Regional Committee member to be present in Conference Hall of ESD, BPC, Gelephu and Conference Hall of BPC, Phuentsholing.
- b. 1400 hours. – 1410 hours: All the bidders who have purchased and submitted the bids shall register and proceed to auction hall by producing money receipt issued during the time of bid registration/submission.
- c. Only one person per money receipt will be allowed to attend the auction
- d. 1415 hours: Arrival of BPC Auction Chairperson and the Auction Committee members.
- e. 1415 hours: The Chairperson shall lead the auction proceedings.
- f. 1420 hours: The Chairperson shall invite a BPC official to announce the property to be auctioned and other relevant information and begin auction by opening the sealed bids one by one and recording the entry as per designed format/google sheet.

- g. 1420 hours. Start opening of bids and its offered price, promptly recorded in the format/google sheet, the EMD submitted along with the bid will be checked, recorded, and evaluated for completeness before the opening of second bid by the Finance & Account team/ committee members.
- h. Subsequently, all the bids will be opened one by one and checked for completeness and record in the designed format/google sheet so that result could be displayed and read out and awarded towards the end by printing and signing of Letter of Award by the Auction Chairperson.
- i. The auction processes to move on till the completion with the decision from the Auction Chairperson.
- j. The successful bidder shall sign the Letter of Acceptance stating that he/she shall abide by the Terms & Conditions of the bid document.
